- * Equipment with a useful life of more than one year and a unit cost of more than \$1,000.
- * The amount of each subcontract above \$25,000 (F&A cost applied to the first \$25,000 for each project period).
- * Hospitalization (patient care costs, both in patient and out patient).
- * Tuition charges from the University of Rochester.
- * Renovation charges.
- * Fully-costed machine shop charges.
